

Ordinance No. 2024-05

ORDINANCE LEVYING AND ASSESSING TAX FOR THE CARLOCK PUBLIC LIBRARY DISTRICT
IN THE COUNTIES OF McLEAN AND WOODFORD IN THE STATE OF ILLINOIS
FOR THE FISCAL YEAR BEGINNING THE 1ST DAY OF JULY 2024 AND ENDING THE 30TH DAY OF
JUNE 2025.

WHEREAS, the President and Board of Trustees of the CARLOCK PUBLIC LIBRARY DISTRICT,
in the Counties of McLean and Woodford, in the State of Illinois, passed the Annual Budget and
Appropriation Ordinance for the fiscal year commencing on July 1, 2024, and ending on June 30,
2025 (Ordinance Number 2024-03) on July 16, 2024; and

WHEREAS, the Annual Budget and Appropriation Ordinance was published, as required by
law, after its passage;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
CARLOCK PUBLIC LIBRARY DISTRICT in the Counties of McLean and Woodford, in the State of
Illinois, as follows:

Section I: That the total sum of TWO HUNDRED THIRTY-THREE THOUSAND FIVE
HUNDRED FIFTY DOLLARS (\$233,550) composed as follows: The sum of ONE HUNDRED EIGHTY-
FOUR THOUSAND NINE HUNDRED DOLLARS (\$184,900), required for the necessary corporate
purposes of the CARLOCK PUBLIC LIBRARY DISTRICT; the sum of TWENTY-FIVE THOUSAND
DOLLARS (\$25,000), required for building maintenance purposes; the sum of TEN THOUSAND
ONE HUNDRED SEVENTY-FIVE DOLLARS (\$10,175), required for the employer's portion of Social
Security and Medicare contributions for its employees; and the sum of THIRTEEN THOUSAND
FOUR HUNDRED SEVENTY-FIVE DOLLARS (\$13,475) necessary for the purpose of payments of
premiums to purchase liability insurance, property damage (fire) insurance, and for risk
management, loss control, and legal fees for defending or otherwise protecting itself against
liability; be levied and assessed upon all taxable property within this Library District according to
the full fair value as established and ascertained for State and County purposes for the fiscal year

beginning July 1, 2024, and ending June 30, 2025.

The Board of Trustees of the CARLOCK PUBLIC LIBRARY DISTRICT passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning on July 1, 2024, and ending July 30, 2025, at its Board Meeting on July 16, 2024. The Budget and Appropriations Ordinance was only passed after a properly noticed public hearing was held and the Board concluded that the specific purposes and amounts listed in the Annual Budget and Appropriations Ordinance are required and necessary for the operation of the CARLOCK PUBLIC LIBRARY DISTRICT, and therefore, the amounts listed do need to be levied. The Annual Budget and Appropriations Ordinance was published, after its passage and adoption, in a newspaper of general circulation within the Library District, as required by law.

Section 2: The Secretary of the Board of Trustees of the CARLOCK PUBLIC LIBRARY DISTRICT is directed to file a certified copy of this Ordinance with the County Clerks in McLean and Woodford Counties in Illinois, in accordance with the laws of the State of Illinois, on or before the last Tuesday of December 2024. The County Clerks are authorized and directed to extend the taxes levied by this Ordinance, according to law, against all taxable property within the CARLOCK PUBLIC LIBRARY DISTRICT. The Secretary of the CARLOCK PUBLIC LIBRARY DISTRICT shall also file, on or before the last Tuesday of December 2024, certified copies of the Annual Budget and Appropriation Ordinance and this Ordinance with the CARLOCK PUBLIC LIBRARY DISTRICT where they shall be available for public inspection.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

**TRUTH IN TAXATION
CERTIFICATE OF COMPLIANCE**

I, the undersigned, hereby certify that I am the presiding officer of the CARLOCK PUBLIC LIBRARY DISTRICT and as such presiding officer, I certify that the levy *Legal Name of Taxing District* ordinance, a copy of which is attached, was adopted pursuant to ,and in all respects in compliance with the provisions of Sections 18-60 through 18-85 of the "Truth in Taxation" law.
